

Articulation Agreement Between

St. Francis College (SFC)
179 Livingston St, Brooklyn, NY 11201

and

Brooklyn Technical High School (Brooklyn Tech)
29 Fort Greene Place, Brooklyn, NY 11217

Upon successful completion of graduation requirements at Brooklyn Technical High School ("Brooklyn Tech"), students will be eligible for admission to St. Francis College (SFC) as candidates for the Bachelor of Science or Arts degree, with an emphasis on streamlined credit transfer and clear advancement opportunities.

Articulation Details:

Student Admission Criteria:

Brooklyn Tech students will qualify for admission to St. Francis College by meeting one of the following standardized testing benchmarks:

All Majors (except for Nursing):

- Cumulative GPA of C (70) Average or better
- Students with GPA of A (90+) or better will receive automatic placements into our Honors Program.

Nursing:

- Cumulative GPA of B (85) Average or better
- SAT score of 1050 or higher; or
- ACT score of 21 or higher.

All Brooklyn Tech students seeking admission must complete an admissions application on SFC's website at <https://www.sfc.edu/admissions-aid/apply-online>. Notwithstanding the foregoing, SFC reserves the right to deny admission under this Articulation Agreement in its sole discretion to any Brooklyn Tech student who has a history of behavior which violates SFC's student Code of Conduct.

Blanket Credits for AP and PLTW Courses:

SFC acknowledges the rigor and comprehensive nature of Brooklyn Tech's curriculum. Accordingly, SFC will grant blanket college credits for:

- Advanced Placement (AP) classes with a score of 3 or higher.
- Project Lead The Way (PLTW) courses successfully completed by Brooklyn Tech students with a final course grade of 70 or higher. These will be accepted by SFC as general electives.

Limitation on Advanced Standing:

Incoming students will be granted a maximum advanced standing of sophomore-level status (30 credits) upon admission to SFC.

Administrative Responsibilities:

SFC will designate an Enrollment Specialist to facilitate the application processes, assist with admission procedures, financial aid and scholarship applications.

SFC will designate an academic advisor to facilitate preferred course registration, onboarding, Honors Program placement, and advisement throughout their enrollment at the College.

Financial Aid and Scholarship Considerations:

In addition to the Annual Scholarship (described below), students from Brooklyn Tech will have access to all applicable financial aid benefits as per current SFC guidelines. Scholarship awards will reflect academic performance, with eligibility determined by annual guidelines. Students must file the FAFSA and complete any other required applications to receive federal, state or institutional aid.

Student Opportunities and Benefits:

Each Brooklyn Tech student will receive an automatic annual and renewable scholarship of up to \$15,000 ("Annual Scholarship"). For illustrative purposes, if tuition is \$30,000, after a \$15,000 scholarship, Brooklyn Tech students would pay \$15,000, before federal and state financial aid and any other institutional merit awards or scholarships awarded by third parties. A student who receives full financial aid (\$13,060 in PELL & TAP awards), would pay \$1,940 out of pocket.

Personalized Honors Program featuring highly engaged faculty.

Opportunities for research, international study, internships, externships, and career placement programs.

Guaranteed admission pathways into St. Francis College's graduate programs.

Promotion/Outreach

Brooklyn Tech agrees to provide its students with information regarding the scholarship, transfer credit, and application assistance benefits available to them under and publicize the existence of this Agreement. Brooklyn Tech and SFC agree to collaborate in order to ensure successful admissions to SFC. SFC grants Brooklyn Tech a temporary, revocable license to use its name, logo and other trademarks solely for the purposes of promoting this Agreement.

Amendments and Termination:

This agreement may be amended through mutual written consent from both institutions. Either party may terminate this agreement with a minimum twelve-month advance written notice. This Agreement shall be governed by and construed under the laws of the State of New York.
