B. ADMISSION REQUIREMENTS

- The A.A.S. Accounting degree and a minimum GPA of 2.0
- Grade of C or better in all credit-bearing **major** courses
 - 'Pass' grades are not acceptable*
- Grade of D or better in all credit-bearing **non-major** courses
 - 'Pass' grades are not acceptable*
- *'Pass' Grades Policy Update: Pass grades are not accepted. Exceptions may be made for semesters impacted by COVID 19. Please see SFC policy for more information.

C. DEGREE OPTIONS

St. Francis College offers 2 degree tracks in the Accounting major:

- CPA Track - Combined Bachelor and Master of Science in Accounting Degree (BS/MS)
 - i. Separate admissions requirements must be met before acceptance into the master's degree portion of the program. Acceptance is competitive and not guaranteed. Students who do not meet the acceptance criteria are able to choose from one of the other degree tracks offered.
- NON-CPA Track – 130 Hour Bachelor of Science in Accounting Degree (ACC)

As per SFC and NY State policy, 30 institutional credits must be completed at SFC and at least 120 credits must be completed overall.

Successful completion of all above requirements will result in a Bachelor of Science in Accounting degree awarded from St. Francis College. Upon acceptance into and completion of the necessary coursework, student may also earn a Master of Science in Accounting degree awarded from St. Francis College.

F. PATHWAY-SPECIFIC ARTICULATED EXCEPTIONS

Transfer Policy Exception: St. Francis College's Accounting program has a stringent transfer credit policy which applies to all students outside of specific transfer pathways and articulation agreements.

Typically, students from two-year institutions are eligible to transfer credits into the SFC accounting program as follows:

i. Students from **2-year institutions** will be allowed to transfer up to four (4) of the following courses:

1. ACC 1101- Elementary Accounting I
2. ACC 1102- Elementary Accounting II
3. ACC 2201- Accounting Information Systems
4. ACC 3301- Cost Accounting
5. ACC 4501- Taxation for Individuals

Any other ACC course will be accepted as an Elective only and will not count toward any Accounting major requirements.

For the purposes of this agreement, the department waives the above stipulation and will accept all 6 major required accounting courses listed in the agreement, which include:

1. ACC 1101- Elementary Accounting I
2. ACC 1102- Elementary Accounting II
3. ACC 2101- Intermediate Accounting I
4. ACC 2201- Accounting Information Systems
5. ACC 3301- Cost Accounting
6. ACC 4501- Taxation for Individuals

G. FOLLOW-UP PROCEDURES

Procedures for reviewing or modifying this Transfer Pathway Evaluation: Annually; Or, when either of the degree programs involved in this Transfer Pathway Evaluation undergoes a change, the Transfer Pathway Evaluation will be reviewed and revised accordingly by faculty from St. Francis College's respective departments or programs. Updated copies of the Transfer Pathway Evaluation will be signed when a new course catalogue includes relevant changes to the courses/requirements listed above.

Procedures for terminating Transfer Pathway Evaluation: SFC may terminate this Transfer Pathway Evaluation for any reason with ninety (90) days' notice. Every effort will be made to facilitate the transfer of students who enrolled under the Transfer Pathway Evaluation before the time of termination.

Procedures for publicizing Transfer Pathway Evaluation: This Transfer Pathway Evaluation will be publicized on the website of the Receiving Institution.
